LIFETIME STAIN RESISTANCE WARRANTY / LIFETIME FADE RESISTANCE WARRANTY

The Manufacturer warrants its PureColor tufted carpet in accordance to the terms stated below. Warranties will vary based on construction of the carpet. Warranties commence on the date of proper installation for PureColor: *Conversion, Defender, Franchise, End Zone, Hall of Fame, Heisman, Lacy, Press Box, Sequence, Time Out, and Vivid Touch.*

100% PureColor tufted carpet is warranted against excessive surface wear under normal use. Excessive surface wear means loss of more than 10% by weight of face fiber. Testing will be commissioned by a third party laboratory at The Manufacturers' recommendation. Any area showing greater wear under conditions of normal use will be replaced at The Manufacturer's expense, including labor charges.

This warranty applies only to carpeting and does not extend to tears, pulls, cuts, pilling, burns, matting, crushing, watermarking or damage due to improper cleaning agents or methods or lack of protections under roller caster or damage resulting from negligence, improper use or natural disaster.

CARPET INSTALLED ON STAIRS IS NOT COVERED UNDER THIS WARRANTY

This warranty specifically excludes carpet which has been surface treated with materials not recommended or approved by The Manufacturer, or which has been subjected to abnormal use or conditions or to cleaning agents or maintenance methods not recommended or approved by The Manufacturer. All carpet and rug maintenance cleaning products, maintenance equipment and maintenance systems must be certified through the Carpet and Rug Institute (CRI) Green Label and Seal of Approval Programs. Approved products are listed on the CRI website at www.carpet-rug.org.

In the event that PureColor Tufted Carpet fails to perform as warranted, contact The Manufacturer's Technical Service Department at 706-625-4334. We require our Technical Service Representatives to inspect and analyze the carpet before any replacement is made.

The Manufacturer will take whatever remedial action is necessary to resolve any carpet exhibiting manufacturing defects at The Manufacturers' expense, including labor charges.
